

Bake Day Online Entry Form

The 2022 Bake Day Contest will be held November 5, 2022 at 4-H Field Day, at the Kern County Fair Grounds in Bakersfield.

Check-in for entries will be from 8-8:45 a.m.

Bake Day Rules:

- 1. ONE ENTRY PER MEMBER, with the exception of the "Whole Grains" category. Any 4-H member, 4th Grade and above may enter in the regular judging part of the contest; Cloverbuds may enter but only in the Cloverbud category. (Third grade members who were age nine on January 1, 2022 are considered to be regular members and are eligible to enter the judging contest.)
- 2. All cakes should be place on a **non-returnable** carrier appropriate to the size of your entry.
- 3. Attach a removable identification label with **NAME, GRADE IN SCHOOL** and **CATEGORY** to your entry. If a cake is covered with plastic wrap, please put the label on the outside.
- 4. Attach the recipe or a list of ingredients, for all baked entries. Packaged mixes are acceptable, with the exception of the "Whole Wheat" category. (Example of a recipe mix card: Chocolate cake mix, added cherries.) You do not need to include the brand name.
- 5. <u>NO entries will be transferred to another category.</u> Entries entered in the wrong category will be judged in the category entered, but will be ineligible for awards. Late entries <u>will not be judged</u> for awards. Registration is from 8:00-9:00 a.m. the day of the event.
- 6. Decorated cakes <u>must be baked</u> by the member. The design should be applied by use of decorating tips. Some small purchased figures are permissible. Permanent portions of the decorated cake will be returned upon request immediately following the contest. <u>Originality is important!</u> Decorated cakes will be judged on outside appearance (30%), originality (20%), inside texture and moisture (20%), and workmanship and color combination (30%).
- 7. The "Chocolate", "White", or "Other Flavors" categories may be a sheet or layered cakes. These designations refer to the flavor of the cake only. Frosting may be any flavor.
- 8. For safety reasons, **NO** cream pies or frostings and fillings made with whipping cream, sour cream or other cream products will be accepted. If the entry requires refrigeration, it will **NOT** be accepted, so please make wise selections!
- 9. **Whole Grains:** Members entering the "Whole Grains" category are not limited to the type of item they make, with the exception of rule #8. The "Whole Grains" item must be made from scratch, with the ratio of flours or grains used being no less than 75% whole grains. Suggestions for this category include; but are not limited to, the use of whole wheat flour, potato, rye, and rolled oats. The use of white flour in this category must not exceed 25% of the total grains used. Members participating in this category will be allowed to enter a second category. A separate (second) baked item must be entered in a different category.







4-H Shooting Sports – Air Rifle Project Schedule – Fall 2022

Project Leaders: John Borba, John Carter

You must be at least nine years old or in the 4th grade to participate and fill out a 4-H enrollment form online. If you are currently a 4-H member you must add "Shooting Sports – Rifle" to your projects in the online enrollment system.

This project will involve the basic techniques of safety and air rifle marksmanship. All sessions will take place at Pro Tool Services, Inc., 1704 Sunnyside Court, Bakersfield, CA 93308. Each member is expected to demonstrate proper safety procedures with a .177 caliber air rifle.

If any student has a learning disability, the parent should meet with the leader prior to the class to inform him of any special needs. Students may use a privately owned rifle for the provided they are in safe operating condition with iron sights (no scopes).

All equipment will be provided.

All sessions will begin at 5:30 p.m. and end at 6:45 p.m.

Explorers of the Deep

Explorers of the Deep, focuses on the mysteries and adventures of ocean exploration—with robots! Young people learn how to use science, technology, engineering, and math (STEM) to explore Earth's Ocean and how it relates to all life on the planet.

Explorers of the Deep activities can be done all at once or individually.

- 1. **Ocean Robot Test Tank** is an activity where youth learn how to "ballast" their ocean robot by adding weights to replicate the sinking and floating behavior of a real ocean robot. They will investigate data collected by ocean robots and learn about the value of ocean exploration.
- 2. **Ocean Expedition** is a board game where youth navigate their ocean robot around the world while learning key ocean concepts. Topics include aquaculture, climate change, innovation, human impact and the ocean ecosystem.
- 3. **Ocean Communicator** is an activity in which young people investigate challenges that ocean scientists, engineers and technologists are currently exploring. They design and advocate for innovations and technical solutions that inspire public action.




Design and Build a Solar Car

Youth Loans

FACT SHEET August 2019

Overview

The U.S. Department of Agriculture's Farm Service Agency (FSA) makes operating loans of up to \$5,000 to eligible individual youths ages 10 to 20 to finance income-producing, agriculture-related projects. The project must be of modest size, educational, and initiated, developed, and carried out by youths participating in 4-H clubs, FFA, tribal youth organizations, or similar agricultural-affiliated groups.

The project must be an organized and supervised program of work. It must be planned and operated with the assistance of the organization advisor, produce sufficient income to repay the loan, and provide the youth with practical business and educational experience in agriculture-related skills.

Who May Borrow

To qualify for a loan, the applicant must:

- Comply with FSA's general eligibility requirements;
 and
- Conduct a modest income-producing project in a supervised program of work.



How Loan Funds May Be Used

These loans can finance many kinds of income-producing agricultural projects. The loan funds may be used to:

- Buy livestock, seed, equipment, and supplies;
- · Buy, rent, or repair needed tools and equipment; and
- · Pay operating expenses for the project.

How It Works

To apply, the applicant must submit completed plans and budgets signed by the project advisor and parent or guardian along with the FSA application for loan assistance.

These loans

- Have a maximum loan amount of \$5,000 (total principal balance owed at any one time cannot exceed this amount);
- Have an interest rate that is determined based on the cost of money to the federal government (after the loan is made, the interest rate for that loan will not change);
- Will be secured, in addition to promissory notes, by liens on the products produced for sale and on chattel property, including livestock, equipment, and fixtures purchased with loan funds; and
- Have a repayment schedule that varies depending on the type of project for which the loan is made. For example, if it involves raising livestock or crops, the loan is paid when the animals or produce are normally sold.

Online 4-H Treasurer Training Course
