

The Ag Burn Alternatives Grant Program provides incentives to utilize an alternative practice for the disposition of agricultural material from orchard/vineyard removals as an alternative to open burning. In addition, the program provides incentives for the purchase of new agricultural woodchipping equipment to chip orchard and vineyard removals located within the San Joaquin Valley. Complete applications are processed on a first-come, firstserved basis while funds are available.

## News Updates: USDA Announces \$7.7 Billion for Climate-Smart Agriculture Practices

"Earlier this month, the USDA announced \$7.7 billion to support voluntary conservation programs through the Natural Resources Conservation Service (NRCS). Most of the money comes from the Inflation Reduction Act, with some from the Farm Bill, and will help expand programs like the Environmental Quality Incentive Program. The NRCS also added 14 new activities to its Climate-Smart Agriculture and Forestry Mitigation list." -Kern County Farm Bureau
