- *Please remember once you send an email you are registered for the show. Your entries fees are due even if you are unable to attend. *Day of show entries will NOT be accepted.
- *Tattoo changes only are allowed. Rabbits entered in fur MUST ALSO be entered in the regular show in their respective breed classes. It is your responsibility to check entries for errors NO DAY OF SHOW CHANGES
- PLEASE MAKE CHECKS PAYABLE TO: KCRBA
- Email entries will be accepted and confirmation will be given. If you do not receive confirmation, please contact the secretary. Any email entries made must be paid for even if you do not attend the show.
- No late entries will be accepted. No day of show entries or add-ons.
- A \$25.00 fee will be charged for all returned checks. All fees owed must be paid prior to the start of the show!

Show Rules

- 1. All rabbits/cavies must have permanent, LEGIBLE, ear mark/tag in the animal's left ear. This rule will be STRICTLY enforced.
- 2. Any sick animal must be removed from the show room/area.
- 3. Exhibitors are responsible for getting their animals to and from the judging tables. No class will be re-judged due to late or missing animals, per ARBA Show Rules. No refunds will be given for missed classes for any reason. NO EXCEPTIONS!!!
- 4. All animals are entered at the owner's risk. Show personnel and judges are not responsible for injury or loss of animals. All precautions will be taken to prevent injury to all animals.
- 5. The show committee reserves the right to substitute or add judges as necessary.
- 6. Absolutely NO animals other than rabbits or cavies, with the exception of certified animals, will be permitted in the show room.
- 7. Absolutely NO ALCOHOLIC BEVERAGES and NO SMOKING will be allowed in the building.
- 8. Show room etiquette will be strictly enforced. Violators will have an elimination of their entries and forfeiture of their entry fee.
- 9. PARENTS OR GUARDIANS MUST CONTROL THEIR CHILDREN. You will be held responsible for any damage to the Ag Pavilion and any equipment. ABSOLUTELY NO SKATEBOARDS, ROLLERBLADES, BICYCLES OR SCOOTERS ON THE GROUNDS.
- 10. No sale of merchandise (other than animals) will be allowed in the showroom unless booth space has been arranged for and paid. Sale rabbits must fit in the space allotted for your entries.
- 11. It is the responsibility of the exhibitor to pick up remark cards, if provided, when removing animals from the judging table. ALL awards MUST be picked up the day of the show, they WILL NOT be mailed. LEGS WILL BE EMAILED WITH THE SHOW REPORT.
- 12. Judges decisions are FINAL. Entries may be withdrawn from competition by the committee and/or judges at their discretion, and entry fee forfeited for interference with the judging process. Indicating ownership of an exhibit will be considered interference.
- 13. No one will be allowed behind the judging table without the permission of the table ramrod or clerk.
- 14. Failure to adhere to the above stated rules or those of the ARBA will be grounds for forfeiture of your entire entry.
- 15. Any discrepancies with the show rules listed here or those of the ARBA will be decided by the KCRBA Show Committee Officials and judgments made will be final.
- 16. Animals must be kept in standard carriers with solid bottoms. NO PLAYPENS!
- 17. No changes will be allowed at the table without the show secretary's approval and signature or the rabbit will be disqualified.
- 18. Submission of a show entry and fee acknowledges your willingness to abide by the above show rules, including all ARBA Show Rules.
- 19. The American Rabbit Breeders Association will cancel and reschedule sanctions at no cost to the clubs for show site locations within 125 miles, which had a confirmed outbreak of RCV/RHD/VHD in domestic rabbits within the past 60 days of the entry deadline. A host club must refuse entries from exhibitors placing an entry from all locations within 125 miles, which had a confirmed outbreak of RCV/RHD/VHD in domestic rabbits within the past 60 days of the entry deadline.
- 20. The American Rabbit Breeders Association will cancel and reschedule sanctions at no cost to the clubs for show site locations within 30 miles, which had a confirmed outbreak of RCV/RHD/VHD in wild / feral rabbits within the past 60 days of the entry deadline. A host club must refuse entries from exhibitors placing an entry from all locations within 30 miles, which had a confirmed outbreak of RCV/RHD/VHD in wild / feral rabbits within the past 60 days of the entry deadline.
